



Year 7 Postcard Competition Terms and Conditions

The organiser is: the Data Protection Authority whose office is at St Martin's House, Le Bordage, St Peter Port, GYI IBR. The competition is being run by the Office of the Data Protection Authority ("the ODPA").

- 1. These terms and conditions are for entrants of the ODPA's Year 7 postcard competition. They explain what the rules are and what will happen.
- 2. When you enter this competition you also agree that you will follow these terms and conditions.
- 3. This competition will open on the first day of term January 2023 and ends at midnight on 31 January 2023. The winner will be chosen as soon as possible after this date.
- 4. If the ODPA has reason to believe your entry is not your own work or otherwise doesn't meet these terms and conditions, it may, without consulting any other party, disqualify it, without explanation or notice.
- 5. There is no entry fee and no purchase necessary to enter this competition.
- 6. The winning idea will be selected by a panel of judges from the staff of the ODPA, Resolution IT and the Youth Commission. Entries will be judged solely upon their content, with the entrants' personal details not visible to the panel. The panel will not include anyone with children in the current year 7.
- 7. The ODPA's decision for all matters to do with this competition will be final and it will not discuss its decision with the winner or any entrants.
- 8. This competition is only open to Year 7 students within the Bailiwick of Guernsey.
- 9. The prize consists of one laptop computer donated by Resolution IT.
- 10. The prize is the laptop, and no cash or other alternatives will be offered. The prize is non-negotiable and is not transferable (it can't be swapped for something else).

- 11. There will be only one winner of the laptop.
- 12. The ODPA will notify the winner via their school.
- 13. Unsuccessful entrants will not be notified.
- 14. The ODPA reserves the right to invalidate, suspend, cancel or amend this competition, if it becomes necessary, without giving any notice.
- 15. The ODPA has the right, without consulting anyone else, to change or modify these terms and conditions as necessary and at any time.
- 16. If it's relevant and necessary, you will be notified of any changes to this competition as soon as possible by contact with your school.
- 17. This competition and these terms and conditions will be governed by Guernsey Law and any disputes will be subject to the exclusive jurisdiction of the courts of Guernsey.
- 18. The ODPA will only keep the contact details of entrants long enough to award the prize.
- 19. Entrants can withdraw from the competition at any time but once an idea is submitted to the competition it can be used by the ODPA without a fee and for as long as needed in promotional materials. This includes the ODPA's website and printed resources. You will not be identified as the author.
- 20. The winner does not have to agree to carry out any publicity regarding their entry. Once the winner is chosen, they can decide if they want to participate as long as their parents, carers or legal guardians agree.
