This month's update from our Commissioner, Emma Martins

I am writing this after attending the last public engagement of my term (my thanks go to the Chamber of Commerce and Richard Field). It has always been one of the highlights of my role to be privileged to speak to and with our community - to talk about the work we do and the reason it matters.

These are always enjoyable events but there is a serious side because they are also about accountability. We have been given significant responsibilities and powers under the <u>Law</u> and how we exercise them matters.

I want us to be accountable for everything we do, and don't do (because inaction can also have consequences).

I know we have been back to 'normal' for a while now, but I still find myself appreciating in-person events much more than I did prepandemic. Artificial Intelligence may be able to do lots of brilliant things, but it cannot (in my view) replace human to human communication. It has been another busy month in the world of data, both locally and beyond. To mark **UNICEF's World Children's Day** we launched a public consultation as part of our work on a **Children's Framework** to support the responsible use of children's information, together with a **blog** setting out why involving and considering our younger generation is so vital.

The rollout of our storybook <u>Warro</u> has continued and we have been delighted with the responses of the children (and teachers!). The Bailiwick schools have been wonderfully supportive, and it illustrates so beautifully the power and potential of community.

Further afield, it does feel as though there has been a shift in conversations about AI recently.

We are seeing more considered and thoughtful deliberations around some of the real-world impacts these technologies are having and that has to be a good thing.

There is the potential for these innovations to do so much good but we need to get better at understanding and preventing the harms. Even those of us working in this field have a difficult time keeping up with developments so we have published a short **global AI regulation update**. These things may feel distant, but they increasingly impact us all.

Responding to this shared global challenge is at the core of the work being done by the **Global Privacy Assembly (GPA)**. It meets annually to bring together regulatory authorities and data protection professionals from around the world, to discuss global threats to information security and debate potential solutions.

Especially as a small jurisdiction with limited resources, we can benefit from working with and learning from other regulators.


