



Medical Specialist Group (MSG) issued with Enforcement Order

This sanction follows an investigation into a complaint made by the parents of an MSG patient relating to the processing of their child's personal data.

An update from our Commissioner, Brent Homan

Last month the leaders of the Privacy and Data Protection world gathered in Jersey for the annual Global Privacy Assembly.

Our Channel Island counterparts, the Jersey Office of the Information Commissioner did an outstanding job as hosts, for an event that focused on key global privacy issues ranging from Artificial Intelligence to Children's Privacy.

Guernsey took a leading position in many of these engagements, harnessing the power of partnership to expand capacity and serve the interests of the Bailiwick and its residents.

The week kicked off with the global announcement of our Joint Statement to combat unlawful Data Scraping which can fuel cyber-attacks and lead to serious privacy harms including identity theft. We signed this statement alongside fifteen regulatory partners from every corner of the world.

In addition, we seized the opportunity to expand our capacity and impact through

international cooperation by establishing memoranda of understanding with three other jurisdictions home to leading finance sectors, to enable effective knowledge sharing and cooperation.

The team wasted no time enacting this as counterparts from Bermuda visited the following week to exchange perspectives on effective investigations, breach reporting and community outreach.






Charity Drop-In at Cobo Community Centre
