### **An update from our Commissioner, Brent Homan**

As I raised in June's [Guernsey Press column](#), there is an important conversation happening in the United Kingdom that has reached the shores of the Bailiwick. It has inspired thoughtful and, at times, strident debate amongst parents, educators and leaders, and orbits the central question: "should we ban the use of mobile phones and social media by children?"

In delving into this sensitive issue I concluded that while bans are rarely an effective solution, we should applaud the strong and courageous voices of bereaved parents and concerned community leaders that have sounded this clarion call.

It is often these very "ban calls" that act as catalysts for positive and enduring change. They elevate the priority of a matter on the public stage, encourage

public discourse and provoke leaders in the government and business sectors to take meaningful action. Protecting children's rights is not just a UK priority but a global priority.

To that end, I recently chaired a session on tackling children's privacy issues from different angles at a Privacy Laws & Business conference in Cambridge. Speaking on the Panel, Deputy Commissioner Rachel Masterton discussed at length the difficult and delicate balance needed between regulation, enforcement, education and engagement with governments, educators, parents, carers and children themselves.

In the Bailiwick we received a higher than usual number of breach reports resulting from phishing activities, prompting us to issue a Public Advisory, warning Guernsey residents to be vigilant about suspicious emails and 'think before they click'.

We also published several key pieces of guidance to help organisations comply with the local data protection legislation. This included [advice on using third parties to work with other people's data](#) and [sharing data in health emergencies at work](#).

Finally, our [2023 Annual Report](#) is out now and highlights the excellent achievements realized in 2023, as we progress towards a vision of Guernsey as a model for the global data protection community with a public and private sector that embraces compliance and elevates the level of trust and consumer confidence.





## **Annual Report (2023) published**


Read the Data Protection Authority's Annual Report for 2023 which details the Office of the Data Protection Authority's (ODPA) activities under The Data Protection (Bailiwick of Guernsey) Law, 2017.

### **Key highlights from 2023 include:**

- 12 new guidance notes published to help organisations understand and comply with the law.
- 1,128 children/young people attended ODPA Schools Programme sessions (Project Bijou Seeds).
- 56 new data protection complaints received.
- 151 breaches reported.
- 16 new investigations opened.
- 7 new inquiries opened.



technologies, with a particular focus on online safety, content moderation and platform regulation.


