An update from our Commissioner, Brent Homan

What is a deceptive design? Do you know what is meant by 'dark patterns'?

While you might not be familiar with the terms, you likely encounter them on a daily basis.

Regret signing up to that online clothes outlet promising designer discounts but can't find the unsubscribe button?

Chances are that deceptive design patterns are in play. And they are surprisingly commonplace.

Our office took part in the annual Global Privacy Enforcement Network (GPEN)'s Global Privacy Sweep earlier this year, alongside 52 other data protection and consumer authorities around the world.

Each authority looked for 'dark patterns', which are techniques that drive people

down the least privacy-friendly route, leading users to give up more information than they intend or thwarting attempts to delete data.

The ODPA focused on the gambling sector. We found indicators of 'dark patterns' in every one of the 19 online gaming sites reviewed.

Once the Sweep results were published, the ODPA reached out to all operators of the sites with its concerns, inviting them to improve their data protection practice. And you know what? It worked. An impressive 78% of those companies contacted made commitments to address the ODPA's concerns and improve their practices.

Not a bad result for a small DPA located in the middle of the English Channel. We applaud the willingness of companies to address dark pattern concerns.

Their collective efforts will lead to a greater respect for customers' privacy and consumer rights that will benefit their global customer base. For more details, check out my blog on the issue: [Dark patterns and the gambling industry · ODPA](#)

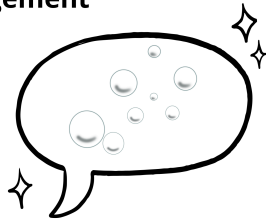

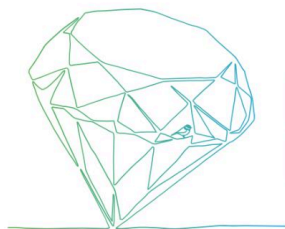
